

Dedalus Transfers iSOFT Nederland B.V. and ExpertDoc B.V. to Total Specific Solutions B.V.

Milan, Italy, 12nd of February 2025 – Dedalus Group ("Dedalus"), the global leader in health software¹, with a vast network of hospitals serving a population of over 540 million patients, has completed the transfer of its subsidiaries, iSOFT Nederland B.V. and ExpertDoc B.V., to the Dutch group Total Specific Solutions B.V. ("TSS") as of November 1, 2024.

iSOFT's solution, MicroHIS, is a complete General Practitioner Information System that provides quality patient care and highly efficient workflows for General Practitioners and their staff. Furthermore, iSOFT specializes in interoperability standards and the exchange of information between healthcare providers, especially hospitals and primary care providers.

ExpertDoc, the second company, has a software solution that adds value to healthcare professionals in all care institutions by providing medical decision support. ExpertDoc combines patient data with medical knowledge from guidelines and protocols.

This strategic divestment of the two companies, both operating in the primary care segment, was motivated by the significant differences between the target markets and operating models of two key sectors in the healthcare system. On one hand, Dedalus serves large public and private clients, while on the other, TSS caters to a diverse range of clients across various verticals, including many smaller healthcare providers such as general practitioners who require immediate support and responsiveness. These two types of healthcare markets and activities are fundamentally different yet maintain an essential connection through shared initiatives for hospital-territory integration.

"Collaboration between primary care and other areas of prevention and treatment remains central to our strategy, which is strongly focused on the Continuum of Care. The partnership between Dedalus and Total Specific Solutions is a key element to ensure the success of new care paradigms both within and beyond the hospital setting," commented Amela Popovac, Regional General Manager of Dedalus Nordics.

Dorinda Van Oosten, General Manager at TSS stated: "We are excited that iSOFT and ExpertDoc have chosen TSS as their perpetual home. Since we





buy once and hold forever, we provide a solid foundation for the future of both companies, their employees, and their customers. By adding iSOFT and ExpertDoc to our group, we can increase our knowledge base in this vertical. This will benefit all our healthcare IT companies and give us the opportunity to explore other possible partnerships".
